1. CALL TO ORDER.

- 2. <u>PUBLIC HEARING LAND ASSESSMENTS.</u> The Board will open the meeting to public comment to hear any comments regarding the District's proposed 2018 land assessment.
- A. Members of the public will be asked for comments regarding the District's proposed 2018 land assessment. Speakers will be asked to state their names and keep their comments regarding the assessment to three minutes.
- B. The Board may discuss and take action to approve the proposed land assessment and authorize the District Manager, officers and consultants to take any action necessary to finalize the assessment.
- 3. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes for the Board's January 10, 2018 meeting.
- 4. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and take action on a variety of matters related to the District's financial status including:
- A. Review and possible approval of bills to be paid by the District and/or ratification of prior payment of those bills.
- B. Review and possible approval of request to dismiss finance charges on the account of East Bay Farms.
 - C. Review and possible approval of prepayment amounts for the Umada account.
- 5. <u>SGMA AND GSPs</u>. Brad Samuelson will be present to announce his departure from Provost and Pritchard and introduce Joe Hopkins as the District's new SGMA consultant. The Board may discuss and take action on establishing an ad hoc committee for SGMA matters.
- 6. <u>EARLY DELIVERIES</u>. The Board may discuss and take action on starting District facilities to make early deliveries of water on a limited basis.

- 7. <u>DISTRICT CLEANUP</u>. The Board may discuss and take action in connection with illegal trash dumping on property within the District. The Board may discuss and approve appropriate methods for trash removal and the possible installation of fencing around parcels owned by the District.

 - A. Update on current District operations.
 - B. Update on the District's annexation project.
- C. Update on the status of the Groundwater Sustainability Plan for the Madera Groundwater Subbasin. The District's consultant may also present information on this topic.

- 9. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.
