CALL TO ORDER - REGULAR MEETING.

- 1. <u>PUBLIC COMMENT DISTRICT MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.
- 2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes for the Board's August 14, 2019 meeting.
- 3. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and take action on a variety of matters related to the District's financial status including:
- A. Review and possibly approve bills to be paid by the District and/or ratify prior payment of prior bills.
- B. Review and possibly approve loan documents from Central Valley Community Bank and authorize District officers and legal counsel to take any other actions necessary to finalize the loan documents.
- 4. <u>DELINQUENT ACCOUNTS</u>. The Board may hear a report on the status of notices of delinquent assessments related to parcels in the District with delinquent accounts.
- 5. <u>DETACHMENT UPDATE</u>. The Board may hear an update from the ad hoc committee regarding the detachment of subordinate lands from Madera Irrigation District ("MID"). The Board may review, discuss and take action on a variety of matters related to the detachment or related water supply agreement including the approval of a letter to affected landowners.
- 6. <u>UDEL UPDATE</u>. The Board may hear a report on the status of the District's 2019 director election.

- 7. <u>WATER GENERATION PROJECTS</u>. The Board may review, discuss and take action on a variety of matters related to increasing water supplies within the District including:
- A. Review and possibly approve water generation projects such as drilling test holes for potential new well sites and/or developing recharge basins.
- B. Hear a report regarding updates on the Madera Lake Project. The Board may authorize District officers and consultants to take such further actions as necessary to move forward with the Madera Lake Project.
- 8. MANAGER'S REPORT. The District Manager will report on current District operations.
- 9. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

ADJOURN AS THE BOARD OF MWD AND CONVENE AS THE BOARD OF THE MWD GROUNDWATER SUSTAINABILITY AGENCY.
