## CALL TO ORDER - REGULAR MEETING.

- 1. <u>PUBLIC COMMENT DISTRICT MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.
- 2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes for the Board's June 10, 2020 meeting.
- 3. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and possibly approve a variety of matters related to the District's financial status including:
- A. <u>Bills</u>. Review and possibly approve bills to be paid by the District and/or ratify prior payment of prior bills.
- B. <u>Water Rate</u>. Discuss and possibly approve landowner request to reduce the 2020 water rate due to potential impacts of COVID-19.
- 4. <u>WATER SYSTEM/WATER DELIVERY SEPARATION</u>. The Board will hear an update regarding the District's operation of its water delivery system to separate surface and

groundwater deliveries to accommodate delivery of surface water to the Madera Irrigation District subordinate lands within the District. The Board may take action in connection with the delivery system including but not limited to adjusting the current delivery schedule. The Board may authorize District officers and consultants to revise the District's current rules and regulations as needed to implement any changes necessary as a result of the District's new delivery system and water segregation.

- 5. <u>MADERA LAKE PROJECT</u>. The Board will hear a report by the District's consultants regarding the status of the Madera Lake Project. The Board may review, discuss and take action in connection with the Madera Lake Project. The Board may authorize District officers and consultants to take such further actions as necessary to move forward with the Madera Lake Project.
- 6. <u>RESOURCE CONSERVATION DISTRICT WORKING GROUP</u>. The Board may hear a presentation from representatives of the local Resource Conservation District about participating in a working group to highlight financial needs for local resource conservation concerns. The Board may discuss participation in the working group and possibly review and approve a letter of support from the District and/or the working group to the State Conservationist regarding increasing the allocation of federal funding for Madera County conservation practices.
- 7. MANAGER'S REPORT. The District Manager will report on current District operations.
- 8. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

## ADJOURN AS THE BOARD OF MWD AND CONVENE AS THE BOARD OF THE MWD GROUNDWATER SUSTAINABILITY AGENCY.
