CALL TO ORDER - REGULAR MEETING.

1. <u>PUBLIC COMMENT – DISTRICT MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.

2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes for the Board's May 12, 2021 regular meeting and the June 1, 2021 special meeting.

3. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and possibly approve a variety of matters related to the District's financial status:

A. <u>Bills</u>. Review and possibly approve May bills to be paid by the District and/or ratify prior payment of prior bills.

B. <u>Review of Financials</u>. Review, discuss and approve financial reports prepared by Blankenship & Company. The Board may also review, discuss and approve options for rebuilding and/or maintaining its reserve fund to ensure funding is available for future District projects.

C. <u>CVCB Loan</u>. Discuss and possibly approve lines of credit or loans offered by Central Valley Community Bank and authorize the Manager and/or District consultants to take such actions necessary to secure such lines of credit or loans. The Board will discuss increasing the line of credit from \$750,000 to higher amounts and the timing on availability of the line of credit. The Board may also review and possibly approve loan documents from Central Valley Community Bank and may authorize the Manager and/or District consultants to take such actions necessary to finalize the loan documents. 4. <u>WATER DELIVERIES</u>. The Board may hear a report from the ad hoc committee regarding estimated water deliveries for the 2021 water year. The Board may also review, discuss and possibly approve a letter to landowners regarding the same.

5. UPDATE ON GENERAL DISTRICT ELECTION; APPOINTMENT OF NEW

<u>DIRECTOR</u>. The manager and general counsel will update the Board regarding the status of the District's general district election. The Board will discuss a potential replacement director to fill the remainder of the term for Director Canales.

6. <u>MANAGER'S REPORT</u>. The District Manager will report on current District operations.

7. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

ADJOURN AS THE BOARD OF MWD AND CONVENE AS THE BOARD OF THE MWD GROUNDWATER SUSTAINABILITY AGENCY.
