CALL TO ORDER - REGULAR MEETING.

- 1. <u>PUBLIC COMMENT DISTRICT MATTERS</u>. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.
- 2. <u>APPROVAL OF MINUTES</u>. The Board may review and approve the minutes for the Board's September 8, 2021 regular meeting.
- 3. <u>FINANCIAL MATTERS</u>. The Board may review, discuss and possibly approve a variety of matters related to the District's financial status:
- A. <u>Bills</u>. Review and possibly approve July and August bills to be paid by the District and/or ratify prior payment of prior bills.
- B. <u>Review of Financials</u>. Review, discuss and approve financial reports prepared by Blankenship & Company for July and August. The Board may also review, discuss and approve options for rebuilding and/or maintaining its reserve fund to ensure funding is available for future District projects.
 - C. Audit Review. Review, discuss and possibly approve the District's annual audit.
- 4. <u>WATER DELIVERIES</u>. The Board will hear a report from the Manager regarding water deliveries and comments and concerns expressed by landowners in connection with same. The Manager will also discuss concerns regarding the 2021 water delivery season if the drought continues and groundwater levels continue to drop. The Board may discuss and take action regarding changes or preparations that may need to be taken with respect to the 2022 water delivery season if the drought continues and little or no surface water is available to relieve

pressure on the basin. The Board may discuss and take action on any other issues that arise from the Manager's report.

- 5. <u>MANAGER'S REPORT</u>. The District Manager will report on current District operations. The Manager will also remind directors of their obligation to obtain ethics training and sexual harassment training every two years.
- 6. <u>RESPONSIBILITY FOR TURNOUT CHANGES</u>. The Board will discuss and may take action regarding responsibility for new turnout due to landownership change.
- 7. <u>TERMINATION OF 2021 WATER SEASON; LANDOWNER LETTER</u>. The Board will discuss and may take action to end water deliveries in the District on or about October 29, 2021. The Board will also discuss and may take action to send a mailing to landowners and water users regarding the 2021 and 2022 water years.
- 8. <u>DIRECTOR COMMENTS</u>. The Board may discuss other items as permitted by the California Government Code.

Written materials related to an agenda item to be considered in open session that are public records will be made available for public inspection upon request.
