**CALL TO ORDER - REGULAR MEETING.**

1. PUBLIC COMMENT – DISTRICT MATTERS. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.

2. APPROVAL OF MINUTES. The Board may review and approve the minutes for the Board’s regular meeting on March 13, 2024. **Action Item.**

3. DEMAND FOR COLLECTOR’S DEED. The board will receive an update and possibly take action related to the appraisal of certain real property for potential acquisition. **Action Item.**

4. FINANCIAL MATTERS. The Board will review, discuss and approve a variety of matters related to the District’s financial status: **Action Items.**

A. Bills. Review and possibly approve bills to be paid by the District and/or ratify prior payment of prior bills.

B. Review of Financials. Review, discuss and approve financial reports prepared by Blankenship & Company.

C. Review 2024-2025 Budget. Review, discuss and consider approval of proposed 2024-2025 District Budget.

5. PUBLIC HEARING ON 2024 WATER RATE. Open Public Hearing and accept comments related to the 2024 water rate.

6. CLOSE PUBLIC HEARING.

7. 2024 WATER RATE. The Board will take action to set 2024 water rate.
8. DISTRICT ELECTION. The Board will discuss and consider taking actions, including but not limited to adoption of necessary resolutions and taking other actions related to the election of the District Board of Directors, as necessary.
9. MANAGER'S REPORT; 2024 WATER DELIVERY SCHEDULE. The District Manager will report on current District operations, maintenance and repairs, and water deliveries. The Board will discuss the current water supply, concerns expressed by landowners within the District and general water supply and district operational issues. The Board may take action to implement one or more new policies in connection with the District's water supply and well capacity.
10. DIRECTOR COMMENTS. The Board may discuss other items as permitted by the California Government Code.
