CALL TO ORDER - REGULAR MEETING.

1. PUBLIC COMMENT – DISTRICT MATTERS. This portion of the meeting is reserved for members of the public to address the Board on items of interest that are not on the Agenda and are within the subject matter jurisdiction of the Board of the District. Speakers shall be limited to three minutes. It is requested that no comments be made during this period on items on the Agenda. Members of the public wishing to address the Board on items on the Agenda should notify the President of the Board when that Agenda item is called and the President will recognize public discussion at that time. It should be noted that the Board is prohibited by law from taking action on matters discussed that are not on the Agenda. Speakers are asked to provide their name and address.

2. APPROVAL OF MINUTES. The Board may review and approve the minutes for the Board’s regular meeting on July 10, 2024. **Action Item.**

3. DEMAND FOR COLLECTOR’S DEED. The board will receive an update related to recording of Collector’s Deed. **Discussion.**

4. FINANCIAL MATTERS. The Board will review, discuss and approve a variety of matters related to the District’s financial status: **Action Items.**

A. Bills. Review and possibly approve bills to be paid by the District and/or ratify prior payment of prior bills.

B. Review of Financials. Review, discuss and approve financial reports prepared by Blankenship & Company.

6. APPOINTMENT OF DISTRICT SECRETARY. The Board of Directors will appoint a Secretary of the Board to replace former Secretary. **Action Item.**

7. VACANCY ON BOARD OF DIRECTORS. Discussion and possible action to appoint Board Member to fill vacancy on Board of Directors pursuant to Government Code Section 1780. **Discussion and Possible Action Item.**

8. MEDICAL BENEFITS FOR EMPLOYEE. The Board will discuss and consider providing medical benefits for District employee. **Action Item.**

9. MANAGER'S REPORT; 2024 WATER DELIVERY SCHEDULE. The District Manager will report on current District operations, maintenance and repairs, and water deliveries. The Board will discuss the current water supply, concerns expressed by landowners within the District and general water supply and district operational issues. The Board may take action to implement one or more new policies in connection with the District's water supply and well capacity.

10. DIRECTOR COMMENTS. The Board may discuss other items as permitted by the California Government Code.
